#### Payment

All Party bookings must pay a non-refundable deposit on conformation of the booking, The Remaining balance should be paid one week in advance of the booking. The person making the booking is responsible for payment.

#### Cancellations

In the case of single bookings if a payment is not received as described above, the booking will not be granted. Cancellations should be reported no later than 7 days before the start of the booking; any cancellations after this point will be liable for the cost of the hire and food. MCLC reserves the right to cancel any bookings of customers whom they deem are continually abusing the system.
